





RESEARCH ACTIVITY

The leading philosophy in the activity as a scholar and researcher has certainly been to privilege those issues that were most relevant to the territorial, economic and social development of the regions of the South of Italy, the context in which the undersigned lives and works. This belief and this choice does not, however, have meant a fall-back into localism, but rather a constant attention and comparison with similar national and international experiences.

Participatory planning and community design.


Currently the main theme on which prof. Fera is focusing his studies and researches is represented by participatory planning as

a tool for the creation and development of local communities. On this issue he founded in 2012 the LabProCom (Community Planning Workshop) a research facility at the University of Reggio Calabria, created in collaboration with the Universities of Messina and Florence. The LabProCom conducts research and training activities on the topic of interactive and participatory planning - design and promotes the spread of a culture of participation and community planning through support and assistance to municipalities and local communities. Within this overall objective, the workshop aims to:

- develop research in the field of techniques and methods of sustainable and participatory planning, with reference to the use of information technology;
- enable training courses for technical experts and facilitators;
- experiment the most effective and appropriate forms of dissemination and transmission of information and knowledge, to promote a widespread culture of participation and sustainable development;
- assisting local communities and institutions in the development of forms of participatory planning and design;
- promote at a community level the making of structures of participation such as permanent Urban centers and Laboratories;
- build a network of relationships with other centers of education and research at national and international level and to strengthen the existing ones.

Currently the LabProCom is collaborating with the City of Messina for the creation of a permanent Urban Laboratory (UrbanLamMe) and is now helping the local Department of Land management and planning in the drafting of the new General Plan, through a series of thematic workshops on the themes of the Messina's landscape, territory and environment, where citizens, companies, associations, public institutions, etc.. are invited to participate.

In past years, prof. Fera has developed experiences of community and participatory planning in several municipalities in Calabria and Sicily, related to *Local Agenda 21* (municipalities of Reggio Calabria and Vizzini) and the *Contratti di Quartiere*, a program for urban regeneration of the National Ministry of Infrastructures and housing, (municipalities of Reggio Calabria, Siderno, Palmi, Rosarno, Vizzini, Melito Porto Salvo, Villa S. Giovanni, Cinquefrondi, Campo Calabro, Cittanova, Paola). In particular, the project designed for the Laboratory of the Tremulini- Borrace District in Reggio Calabria was launched in collaboration with the 'municipal Administration, and won the competition to obtain the funding from the Ministry.



Planning for mitigation of seismic risk.

Professor Fera began the study of urban policies aimed at the prevention and mitigation of seismic risk in 1985-86 at the Center of Environmental Design Research, University of California at Berkeley, under the direction of prof. H.J. Lagorio and at the Bay Area Regional Earthquake Preparedness Program in Oakland. On this subject professor Fera has collaborated with leading Italian research centers, and in particular with the National Group by Earthquakes Defense (GNDT), the National Seismological Service (SSN), the National Department of Civil Protection. He has also worked in different ways with numerous public bodies, including the Calabria Region, the Province of Reggio Calabria, the Province and the city of Messina, etc..



The production of writings on the subject is quite extensive and includes two books, a Dossier edited for Urbanistica, the main Planning magazine in Italy, articles, essays, papers presented in international conferences (in Japan, the Netherlands, Great Britain). A brief list of the main research activities includes:



The planning of natural parks and the promotion of cultural heritage.

Another line of research started in the late 80s is the planning of parks and development policies associated with them. The aim was to focus the attention of the planning and policy intervention "over the border"; that is the areas around the core of the park, in which the human pressure is higher, helped by the prospect of development triggered by the park. A special attention was then turned to seek a proper balance between the seemingly antithetical reasons of conservation and development, focusing on the promotion of local traditional cultures: historical and artistic heritage, rural housing, manufacturing processes, traditional cultures, folklore, poetry, music , crafts, food, etc.. The main research activities have focused on:

1988 Council of Europe-European Campaign for the Countryside-Demonstration project "Nebrodi Park." The project, prepared in collaboration with Meridione Ambiente, a private research institute, of which the undersigned was president, was chosen by the Italian National Committee of the European Campaign for the Countryside, because its significance and interest, to represent Italy at the European Campaign and was presented at the final Colloquium of the Campaign itself, held in Lubeck from 10 to 16 October 1988.

1997-2000. Agreement between Regione Calabria – University of Reggio Calabria, Project of an eco-museum of the Hellenistic culture in the valley of the Amendolea river. The project's objective was to achieve the implementation of an eco-museum of culture in the valley Gracanica dell'Amendolea (municipalities of Bova, Roghudi, Gallicianò) prepared in collaboration with the Regione and the involved municipalities.

The theme of eco-museums is also the subject of the Master of European Heritage Planning and Management.

Informal settlements and policies to support self-help housing.

In the early 80s Professor Fera developed the study of the characteristics and causes of informal urbanization processes,

analyzing in particular the different phenomena that coexist within it (self-construction, illegal business, self-promotion, etc.). On this topic has also developed a line of research related to intervention policies for the control and the upgrading of informal settlements, both in terms of urban plans and production of "facilitated building technologies", with particular reference to the Site and services policies, implemented and funded in the Third World Countries by the World Bank.

On the issue of the development of informal urbanization professor Fera published one monography, in collaboration with Nella Ginateempo, professor of Urban Sociology, published by Franco Angeli, "The Informal Housing in Southern Italy"

The theme of the policies for assisted self-help housing has also been the subject of several workshops that were held in Buenos Aires as part of the project Abitazione at the Facultad de Arquitectura and Urbanismo (FADU), whose theme was precisely the recovery and upgrading of "Villas miseria" in Buenos Aires.
